ABOUT THE COURSE

BACKGROUND

The goal of **Universal Health Coverage (UHC)** is to ensure equity in access to good quality health services and protection against financial risks without hardship. **Availability and access to essential medicines**, which contribute immensely to household and government spending on health, is a core aspect of Universal Health Coverage, and a necessary component of moving towards Sustainable Development Goals. Many households are at financial risk due to catastrophic health expenditures and one of the major factors is the cost of medicines.

This workshop will share with you how leading global health stakeholders are supporting the Universal Health Coverage agenda with the focus on ***access to essential medicines***.

COURSE FEE

- Course fees: **US\$ 2500** which includes:

- Learn about improvements and innovation in access to new medicines
- Achieve personal growth in terms of leadership and management skills linked with global policies translated into local actions

It is targeted at professionals in public health programs (donors, government, private sector, NGOs, civil society, academia) and people interested in global health procurement and supply chain / logistics and universal health coverage.

KEY TOPICS

- **Universal Health Coverage (UHC)- ‘ENSURING HEALTH FOR ALL’:** UHC is about ensuring that people have access to the health care they need without suffering financial hardship. SDG 3 focusses on increasing the efforts made towards achieving UHC by providing timely access to quality essential health care services, access to safe, effective and affordable essential medicines/vaccines and financial risk protection for all.
- **Access to Medicines:** Access to Medicines means access to treatment. Ensuring access to effective treatment is a high priority. The pathway to improving ‘Access to Medicines’ lies in strengthening key levers like health supply chains, financing, investment in training of skilled public health management cadre.
- **Supply Chain- Levels of Maturity:** Procurement and Supply Chain (PSM) represent a continuum of activities which are performed to improve the access to medicines. The work of procuring drugs and medical supplies in a timely way through a supply chain is a very critical step, so that they can reach the people who need them at the ‘last mile’.
- **Key Components of PSM:** Functions in an integrated supply chain include product selection, quantification, forecasting, procurement, quality assurance, storage and distribution, data and information management, and many interconnected steps.
- **Quality Assurance and Regulatory Sciences:** Quality assurance of the medicines is a wide-ranging concept covering all matters that individually or collectively influence the quality of a pharmaceutical product, it also helps ensure that each medicine reaching a patient is safe, effective, and of acceptable quality. Regulatory science focuses on development and application of scientific methods and tools to evaluate the safety, efficacy and quality of medical products to facilitate a sound and transparent regulatory decision-making.
